# MANAGEMENT TRANSACTION

**Lisbon, December 26<sup>th</sup>, 2019:** Pursuant to the terms and for the purposes of article 19 of Regulation (EU) No. 596/2014 of the European Parliament and of the Council and of article 248-B of the Portuguese Securities code, EDP - Energias de Portugal SA ("EDP") provides the following information to the market:
