Lisbon, November 4th, 2020: Pursuant to the terms and for the purposes of article 19 of Regulation (EU) no. 596/2014 of the European Parliament and of the Council, of article 10 of the Delegated Regulation (EU) no. 2016/522 of the Commission and of article 248-B of the Portuguese Securities Code, EDP - Energias de Portugal SA ("EDP") provides the following information to the market and to the public in general:

The member of the Executive Board of Directors, Maria Teresa Isabel Pereira, informed EDP that, on October 30th, 2020, she sold 52,228 shares by an average price of €4.242/share. Following this transaction, Maria Teresa Isabel Pereira reduced her stake to 25,415 shares of EDP.
