The ratio CET1 of the Bank, estimated according to the interpretation made by the Bank of the transitory dispositions of CRD IV/CRR, achieved 12,0% in *phased-in* on December 31st 2014.

According to the most recent information of Bank of Portugal, in the Portuguese Bank sector, the Bank held a market share of 18,9% in clients credits and 18,6% in client deposits, on December 31st 2014. With effect, on December 31st 2014, the Bank positioned itself on the fifth position of the companies listed on the Euronext Lisbon with greater dimension in terms of market capitalization (3.561 million of euros).

On December 31st 2014, the activity in Portugal represented 74% of the total assets, 77% of the clients credit (gross) and 69% of the total client deposits. International operations represent already 49% of the total 1.373 branches and 56% of 17.640



employees of BCP Group. The net results of the international operations shall continue to inforce its importance within the Group results, for the next years. A Remark on the growing dimension of the Bank Millennium operation in Poland, mainly caused by the asset growth, resources and credit. The Bank Millennium in Poland has 423 branches and a share market of nearly 4,7% in client credit and 5,1% in deposits (in December 2014, based on Polish Association Bank), the remarked leadership of Millennium bim in the Mozambican market (in 2014 December: 29,6% in client credit and 30,8% in deposits, according to Mozambique Bank data), the fact of Banco Millennium Angola (BMA) had proceeded with its expansion plan, which contributed to the growth of its distribution net to 88 branches in December 2014, with a market share of 3,6%, in clients credit and of 3,3% for deposits (December 2014, based on Angola Bank).
